CLARIFICATION OF SOLO FREE DANCE REGULATIONS
PAGE 137/138 OF THE CEPA BOOK
PAGE 69/70 OF THE CIPA REGULATIONS

As there seems to be a little confusion over the “Jumps” in Free Solo Free Dance please note the following :-

Youth / Junior / Senior - **only one revolution jumps will be counted as “Jumps” in Solo Free Dance.**

This means that any other jumps of half a revolution or less, will not be considered as Jumps but as part of the technical element of a programme and will be considered as such by the Judges. There is no penalty for half revolution jumps included in a programme in the above categories.

Esplor Solo Free Dance – **it is only allowed to do one jump of one (1) revolution, and one jump of half a revolution in this category.**

The half a revolution jumps means a half revolution of a recognised, named jump (these can be found in the CIPA Regulations pages 157/8/9.
